REFERENCE: Appropriate Section of your Grand Court Bylaws

1. This Form should be sent in the Annual Packet of forms to any Subordinate Court, by the Grand Secretary, which has Past Grand Royal Matrons or Patrons who are entitled to vote at a Grand Court Session.
2. It is intended to be completed and returned to the Grand Secretary by whatever date is required by your Grand Court Bylaws. The names **MUST** be listed in alphabetical order (surname first).
3. Members who are a Past Royal Matron or a Past Royal Patron in their Parent Court and Dual Court are only listed once. They should be listed under the Court where they first received their honors.
4. This Form is provided to the Credential Committee so they can confirm that the Member presenting a credential card is eligible for ballots for Grand Courts Election of Officers.
5. Affix the Court Seal and your signature to the Form prior to mailing or e-mailing.

- 4) Fill in the names of all of the subordinate Court's Past Royal Matrons and Past Royal Patrons in **ALPHABETICAL** order (surname first)
- 5) The Secretary signs and affixes the seal to the form
